



## **Onshore General Skilled Migration visa options**

Australia's General Skilled Migration (GSM) programme is designed to attract skilled people and their families as migrants to Australia.

This flyer only provides general information about visa options for overseas skilled workers. For detailed and up-to-date information please visit the Department of Immigration and Citizenship's (DIAC) website at www.immi.gov.au/skilled/general-skilled-migration/index.htm.

To apply for a GSM visa you must meet some basic requirements (see table below). In addition to the basic requirements, most visas require that you be assessed against a 'points test' and obtain a pass mark (see table on the next page).

The onshore GSM visas are designed for recent graduates who have completed two years of study in Australia and intend to apply for a visa within six months of completing their qualifications. There are also visas for Working Holiday (subclass 417), Occupational Trainee (subclass 442), Skilled - Independent Regional (subclass 495), Skilled - Designated Area-Sponsored (subclass 496), Skilled - Regional Sponsored (subclass 487 and 475), Skilled - Graduate (subclass 485) and Skilled - Recognised Graduate (subclass 476) visa holders.

## **Basic requirements**

If you wish to apply for an onshore GSM visa you must meet all of the following requirements.

English	have good English language ability to be able to work in Australia. A higher level of English is required for some occupations when it forms part of a skills assessment.	provide results of an International English Language Testing System (IELTS) test. (This applies to most applicants). Information about English requirements and contact details for an IELTS testing centre near you are available on the department's website.		
Australian qualification or work experience	have recently completed an Australian qualification after two years full-time study in Australia or more than one qualification totalling at least two years full-time study or have recent relevant work experience.	apply within six months of completing your Australian qualification or have been employed in a skilled occupation for a total of at least 12 out of the last 24 months.
