The Community Leadership and Development Program (CLDP) gives leaders and those who aspire to be leaders in the not for profit and community sector, a chance to build skills for the next challenge in their careers by offering industry leader mentoring and the opportunity undertake University study. CLDP is offering two scholarships with the Sydney Business School, UOW's provider of professional postgraduate business courses. These scholarships, each valued at \$AUD 10,000, cover tuition to undertake a Graduate Certificate of Management at the Sydney Business School's Sydney or Wollongong campuses.

Graduate Certificate of Management

The Graduate Certificate of Management is a flexible tertiary qualification which allows participants to choose 4 subjects from amongst a comprehensive list of subjects taught by the Sydney Business School. Examples of the type of programs undertaken include:

Example Program 1

- Managing People in Organisations
- Accounting for Managers
- Project Management
- Strategic Decision Making

Example Program 2

- Business Coaching
- Quality Management
- Innovation Topics and Cases
- Corporate Governance

Advanced Standing/Credit

Upon completion of the Graduate Certificate in Management students may apply to progress to the Master of Management with credit for subjects completed in the Graduate Certificate. This will not be sponsored by the University.

Eligibility

Applicants for the 2011 Program Community Leadership and Development Program must be in a leadership position, or aspire to a leadership position, in the community or not for profit sector in the Illawarra and South Coast Region or the Sydney metro area. Applicants must have a relevant tertiary qualification along with at least two years professional work experience. People interested who do not have qualifications but who have significant experience at a managerial level will also be considered. It is desirable that applicants are not currently enrolled in a Masters program or have a Masters level degree.

Applicants must also be committed to attendance in the program in which they enrol.

Selection Process

- Complete and lodge the application form.
- A short list is assembled by the CDLP Selection panel and shortlisted candidates may be invited to attend interviews with the CDLP Selection Panel.
- In awarding successful candidates the CDLP panel will consider previous work history, the reasons the applicant wishes to undertake the course and their future career intentions.

Graduating Community Leadership and Development Program Participants

Participants in the program may be asked to communicate their learning experiences to other e.g. in learning forums and at events.
